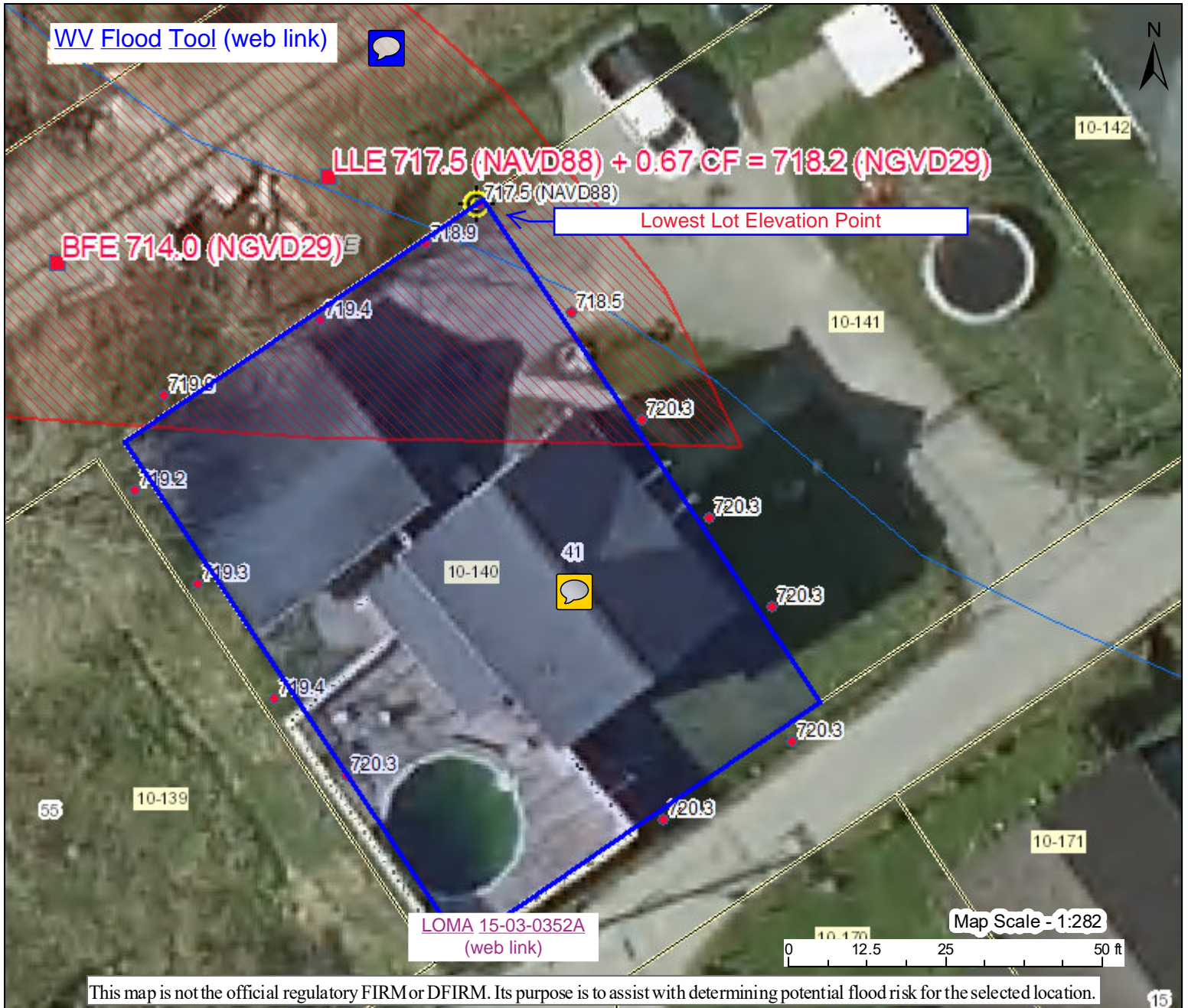


LOMA LIDAR: 41 Lymantary Hill Rd, Holden, W. .
