The Federal Emergency Management Agency (FEMA) is in the process of updating the Flood Insurance Rate Maps (FIRMs) and Flood Insurance Study (FIS) for Monroe County, WV. This study will revise riverine floodplains within your community using better topographic data, as well as current methodologies and engineering practices. The study notification letter was sent to your community on April 20, 2020.

FEMA Region III and its state mapping partner have developed draft riverine floodplain data. The preliminary FIRMs that reflect these riverine floodplains are anticipated to be issued in the Winter 2023.

Before issuing the preliminary FIRMs, FEMA would like to invite the affected communities to a Flood Risk Review (FRR) meeting to review the draft study results and discuss how flood hazard information has changed as a result of the new analysis.
