## IN THE COUNTY COMMISSION OF PUTNAM COUNTY, WV

The County Commission of Putnam County, sitting in regular session this 13th day of December, 2011, does hereby ADOPT the following redistricting plan:

Magisterial District I shall include the following precincts: Precinct Numbers 1, 2, 4, 14, 15, 16, 17, 18, 19, 21, 22, 23, 30, 34, 35, 37, 38 and 40.

Magisterial District II shall include the following precincts: Precinct Numbers 11, 24, 25-1, 25-2, 26-1, 26-2, 27-1, 27-2, 28-1, 28-2, 31, 32, 33-1, 33-2, 41 and 47.

Magisterial District III shall include the following precincts: Precinct Numbers 6-1, 6-2, 7, 8-1, 8-2, 9, 10-1, 10-2, 29-1, 29-2, 42, 43-1 and 43-2.

Putnam County shall consist of three Executive Committee Districts (which shall elect two males and two females from each district in accordance with W.Va. Code §3-1-9 (c)). The Executive Committee Districts shall be the same as the Magisterial Districts (comprised of the same precincts).

It is further ordered that Precinct Number 13 (Central School/Sycamore), Precinct Number 36 (Clendenin) and Precinct Number 48 (Vintroux) be dissolved. Precinct Number 13 (Central School/Sycamore) shall be merged with Precinct Number 10 (Chestnut Grove/Keyser Hts.), which shall be split alphabetically to create Precinct Number 10-1 (Chestnut Grove / Keyser Hts. A-K) and Precinct Number 10-2 (Chestnut Grove/Keyser Hts. L-Z). Precinct Number 36 (Clendenin) shall be merged with Precinct Number 17 (Confidence). Precinct Number 48 (Vintroux) shall be split alphabetically and shall be merged with Precinct Number 28-1 (Bills Creek A-L) and Precinct Number 28-2 (Bills Creek M-Z). The Clerk of the County Commission shall isolate the municipalities of Buffalo, Bancroft, Poca and Winfield - making them their own precinct or precincts. The remaining voters shall be merged with a precinct adjacent to the municipality. For these purposes, three new precincts shall be created. Precinct Number 11 (Winfield) shall lie in Magisterial District II, Precinct Number 10-1 and Precinct Number 10-2 shall lie in Magisterial District III and Precinct Number 14 (Poca) shall lie in Magisterial District I. Due to the decline in voters for Precinct Number 16-1 (Poca Town A-K) and Precinct Number 16-2 (Poca Town L-Z), they shall be merged to make Precinct Number 16 (Poca Town) to respect Poca Town municipal boundaries.

It is further ordered that the polling place location for Precinct Number 32 (Hodges) be permanently changed to The Commons (formerly known as the Museum in the Community).

These changes are being made due to polling place accessibility and the shift in population in accordance with the most recent census. This will be a permanent change effective with the May 8, 2012, Primary Election.

Changing Boundaries of Magisterial Districts II and III RE:

THIS 27th day of October 2015, the County Commission of Putnam County, West

Virginia, sitting in regular session does hereby ORDER the magisterial district boundaries of

Magisterial District II and Magisterial District III amended by relocating the current Precinct 24

of Magisterial District II into Precincts 29-1 and 29-2 of Magisterial District III, thereby

decreasing the boundary of Magisterial District II and increasing the boundary of Magisterial

District III, pursuant to W.Va. Code §7-2-2.

The Clerk has posted notice of said intent on the front door of the Putnam County

Courthouse and at some public place in each Magisterial District II and III, for at least 30 days

prior to October 13, 2015 and today. Further, the Clerk has published said intent to consolidate

Precinct 24 of Magisterial District II into Precincts 29-1 and 29-2 of Magisterial District III as

previously ordered as a Class II-O legal advertisement on August 20, 2015 and August 27, 2015

in The Hurricane Breeze and The Charleston Gazette-Mail Metro Putnam.

No member of the public has appeared to protest or comment with regard to the changing

of Magisterial Districts II and III. Consequently, the County Commission has this day

unanimously voted to ORDER the boundary of Magisterial District II reduced by consolidating

Precinct 24 into Precincts 29-1 and 29-2 of Magisterial District III and thereby increasing the

boundary of Magisterial District III.
