We are pleased to submit the following the proposed price adjustments for the Statewide imagery contract. The Thrasher Group (TTG) has been pleased to support this effort to provide the State and its constituents with this useful and valuable service. TTG has honored the contract and performed all the services at an overall loss/cost for the company for four (4) years. To continue this service, TTG would need to increase costs to the rates listed in the table below in order to cover our expenses for the cost of imagery acquisition and labor for the project. The overall goal is to reach a loss amount of \$0.00 for TTG. We recognize the value this offers the State and the counties that can participate in it. We have devoted much of our business helping communities within this great State to be better and have better services. The originally contracted rates and the resulting cost after applying the correction are as follows:

During the conception of the project, assumptions were made that could have potentially offset the differences with the cost or minor fluctuations between acquisition and labor. After four (4) years of data and reviewing the ever-increasing cost of acquisition, fuel, labor, hardware, and software, the actual cost of the services provided in the contract has become greater than anticipated. We have maintained the costs of the original contract since its inception, but the cost for all things involved have continually, and in some cases dramatically increased. Which is why, at this time we request to update the rates commensurate with the actual costs we've incurred so it is more palatable to perform the work and provide this valuable service.

TTG has been taking many strides to reduce the actual cost of the project overall. We have been able to secure better pricing for acquisition and we have employed the use of summer interns to assist with both the speed and cost of production (these are mostly WV based students). Despite these cost savings efforts, we have remained focused on maintaining the integrity of the project delivering a consistent quality product; however, we have not lowered the cost enough to achieve covering our cost of the acquisition or the labor. The data has been evaluated and the cost in the table above are more reflective of what actual cost of the acquisition and labor cost would be for marketable and competitive rates for this type of acquisition. TTG has an aggressive plan to acquire and process imagery to meet the demands that are posed by the Statewide acquisition and processing as in the past that not many companies have the capabilities to process on the sheer volume of data that must be managed and processed.
