

Subject is a single story brick church sanctuary over a full basement with no vents in the foundation walls. Building is attached to an existing building which is to be removed once coverage is in place. Upon removal, a new building is to be built to join the subject of this certificate to an existing gymnasium, effectively making a single building. Elevation certificate to be revised upon completion of construction to accommodate new configuration.
