Secretary Mills Says Roosevelt Has No Program Meet Economic Situation

Attacks Issues in the Democratic Platform

Boston, July 11. (AP)—Oscar L. Mills, secretary of the treasury, tonight opened the Republican 1932 presidential campaign here with the charge that the Democratic nomination of Roosevelt had no program to meet the economic situation.
